This module is a back protector, satisfying the LTF 2 test. DV LuftGerPV §1, Nr. 7 c corresponding to the ground arrival at 5m/s under an emergency parachute, as well as to the SP 002 12/2016 protocol of CRITT SL. The back protector is not tested for other ground configurations.

Caution :

- *Conform to UE 2016/425 rules*
- *No protector can offer full protection against injuries and in particular that the back protector does not prevent injuries of the spine.*
- *Only the body parts covered by the protection are protected against shocks.*
- *Any modification or misuse can drastically reduce the performance of the back protector.*
